Attached is a screen shot of the Commercial Umbrella billing detail screen. What happened last year was a credit transferred from the classic policy of \$323.00 which left a balance of \$52.00 owed. Then there was a payment made of \$31.25 on November 23rd, 2022 leaving a balance owed of \$20.75. At renewal a paper copy of all documents are mailed out, as that is how it is setup, so there is a \$5.00 fee for the mailed documents. This made the balance due \$25.75 which was then added to the renewal of \$375.00 making the ending balance \$400.75. Please let me know if you have any questions.
